
Growing with HEART


Thank you for believing in our mission and vision, and thank you for an amazing year. We can't wait to see what God has in store for this organization and the people it touches in 2025.

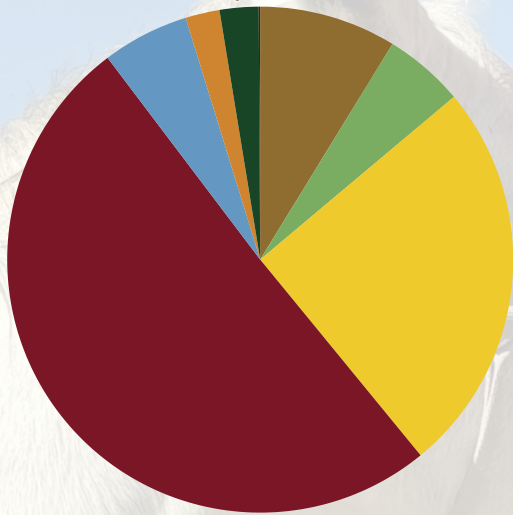

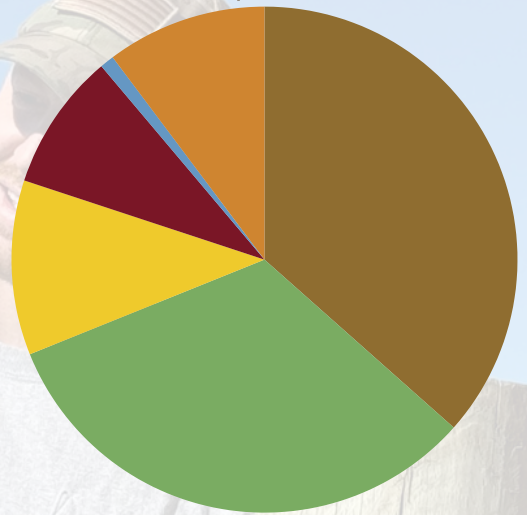
